SPACES LIKE THESE. ONE OF THE THINGS I HAVE COME TO REALIZE

IS THAT WE HAVE, THE STORIES OF THE ELDERS. THE TECHNOLOGY

THAT THEY LEFT WITH US. AND THE KNOWLEDGE. AND YOU KNOW

LOOK SOME TIMES, IT LOOKS LIKE SCIENCE IS TRYING TO -- TO,

CATCH UP TO THAT. SO, THERE HAVE BEEN --

MANY, MANY, INSTANCES WHERE I AM LIKE, HUH, I AM, YOU KNOW,
YOU JUST PUBLISH A PAPER ON THIS. AND IT BECAME LIKE A -BIG THING. BUT, YOU KNOW --

NATIVE WOMEN AND ELDERS HAVE BEEN SAYING THIS FOR MANY, MANY YEARS. SO, IT'S REALLY INCREDIBLE TO HAVE BROOK IN THIS SPACE. I WILL READ THEIR BIOAND THEN WE CAN BEGUN. BROOK, SHE IS A YUROK NATIVE AMERICAN FROM NORTHERN CALIFORNIA, AND PH.D. STUDENT AT, UC SANTA CRUZ IN ENVIRONMENTAL STUDIES. THIS YEAR SHE RECEIVED A MASTERS FROM STANFORD UNIVERSITY IN ENVIRONMENTAL ENGINEERING, WITH A GO CUSS ON WATER RESOURCES AND HYDROLOGY. IN 2020, SHE GRADUATED FROM, PORTLAND STATE UNIVERSITY'S HONORS COLLEGE WITH A DEGREE IN CIVIL ENGINEERING AND A MINOR IN POLITICAL SCIENCE. CURRENTLY BROOK WORKS AS A RESTORATION ENGINEER FOR THE YUROK TRIBE. SHE'S BEEN AN INTERN FOR THE CITY OF PORTLAND, BUREAU OF ENVIRONMENTAL SERVICES, THE U.S. SENATE COMMITTEE ON INDIAN AFFAIRS, WEST COAST ASSOCIATES ENGINEERING AND THE CALIFORNIA WATER RESOURCES CONTROL BOARD. AND SAVE CALIFORNIA SALMON. BROOK IS A GATES MILLENNIUM SCHOLAR, UNITY 2020-25, UNDER 25 RECIPIENT, AND 2017 UNDERGRADUATE AIGC STUDENT OF THE YEAR AWARDEE AMONG OTHER HONORS. BROOK IS, MEGA ACCOMPLISHED. AND YOU KNOW,

WHEN I GROW UP, I WANT TO BE LIKE HER. BROOK'S GOAL TIES BRING TOGETHER WATER RIGHTS AND NATIVE AMERICAN KNOWLEDGE THROUGH ENGINEERING, PUBLIC POLICY, AND SOCIAL ACTION. CURRENT FIGHTS INCLUDE, UNDAMMING THE KLAMATH RIVER, MMIW AWARENESS, SUPPORTING TRADITIONAL ECOLOGICAL KNOWLEDGE, TEK, AND ENCOURAGING WOMEN AND NATIVES IN STEM FIELDS. AND SHE GIVES PUBLIC SPEECHES AND MAKES REALLY, REALLY, BEAUTIFUL ARTWORK TO RAISE AWARENESS ON THESE, USE. SO, ALSO, FOLLOW HER ON INSTAGRAM. OR FOLLOW THE, THE WEBSITE THAT SHE PUT TOGETHER THAT IS ALSO LINKED TO HER INSTAGRAM THAT HAS, ALL OF THESE AMAZING THINGS THAT -- SHE IS DOING. IN THE COMMUNITY. AND ALL OF THE BEAUTIFUL THINGS SHE IS CREATING THROUGH HER ART WORK. SO I WILL STOP TALKING NOW. I AM GOING TO PASS THE, THE MIKE TO, BROOK SO SHE CAN BEGIN HER, CONVERSATION, HER PRESENTATION.

>> PERFECT. OKAY. I WANT TO START OFF BY TALKING, HOW I GOT INTO, ENVIRONMENTAL JUSTICE. AND MY BACKGROUND IN THE FIELD. I TKPWRAOUT UP ON THE YUROK RESERVATION AT THE MOUTH OF THE KLAMATH RIVER, AND MY LIFE REVOLVES AROUND SALMON FISHING AND SO DO MANY TRIBAL PEOPLES LIVES IN THE AREA. YOU CAN SEE WITH MY CUTE LITTLE SALMON ART ON THE RIGHT-HAND SIDE. ALWAYS THE ARTIST LIKE THAT. AND THEN --ME AND MY FAMILY. MY DAD, SPECIFICALLY CATCHING SALMON WITH MY COUSINS. AND THIS IS HOW I SPEND MOST OF MY TIME GROWING UP AS A KID, WAS ON THE RIVER BANKS. FISHING FOR SALMON. AND THEN, WE HAVE COME HOME TO MY GRANDPA'S HOUSE IN THE AFTERNOONS. AND HE WAS THE LAST NATIVE SPEAKER OF MY LANGUAGE, YUROK, I WOULD SPEND TIME WITH HIM. I WAS FORTUNATE TO GROW UP WITH THE TRADITIONS AND CULTURE. KIND OF HOW IT WORKED FOR MY TRIBE. WE DIDN'T HAVE FIRST CONTACT OFFICIALLY UNTIL 1851. THE GOLD RUSH. WE WERE STILL ABLE TO KEEP A LOT OF THE CULTURAL TIES. WHEN I WAS YOUNG IN THE 90S. WE STARTED BRINGING BACK OUR DANCES, WHICH WERE ILLEGAL UNTIL THEN. I HAD THE PREUF LIMB TO GROW UP WITH THE LANGUAGE IN THE HOUSEHOLD. WITH MY GRANDFATHER AND GROW UP WITH MY CULTURE. (PRIVILEGE) HEALING CEREMONIES. ONE THING ABOUT MY TRIBE, WE DON'T REALLY HAVE SOCIAL DANCES. ALL OF OUR DANCES ARE AROUND HEALING EITHER PEOPLE OR THE EARTH. KNOWLEDGE AND SPIRITUALITY THAT GO INTO EACH OF THE CEREMONIES WE DO SEVERAL TIMES OVER THE SUMMER, HAD THE PRIVILEGE THROUGHOUT MY LIFE. A TURNING POINT FOR ME WAS WHEN I WAS 7 YEARS OLD. I WAS --

IT WAS THE MORNING AFTER ONE OF THE CEREMONIES WHICH YOU SAW ON THE LAST PAGE. AND --

I -- I GOT DONE WITH THE CEREMONY WITH MY PARENTS. IN A

TENT CAMPING. WE HEARD PEOPLE TALKING ABOUT THE -
TALKING ABOUT THE RIVER. FISH DYING. NEED TO GET TO THE

RIVER RIGHT NOW. SO I REMEMBER KIND OF IN THE MISTY

MORNING. FOGGY MORNING ON THE RIVER, TRY TO LOAD A LITTLE

PHOTO CO-HRAPBLG HERE, I WALKED OUT OF THE TENT WITH MY

MOTHER. AND HOLDING HER HAND, WE WALKED ALONG THE SHORE.

(COLLAGE) WHAT WE SAW CHANGED THE REST OF MY LIFE. NEXT

SLIDE. THERE WERE THOUSANDS AND THOUSANDS OF DEAD SALMON

LINING THE SHORE LINES. SALMON THAT WERE ALIVE THE DAY

BEFORE. AND, FOR ME, THIS WAS -- REALLY TRAUMATIC. NOT ONLY

BECAUSE SALMON, YOU KNOW, IS, REVOLVES AROUND THE WHOLE

LIFE. HOW I SPEND MY SUMMER. AND EVEN HOW I PAID FOR MY

SCHOOL CLOTHES FROM A YOUNG AGE. I GOT MY FISHING LICENSE AT 12, ACTUALLY. I PAID FOR ALL OF MY OWN SCHOOL CLOTHES AND SUPPLIES GROWING UP BY SALMON FISHING AND WORKING ALL SUMMER. BUT -- FOR ME THIS IS A DEATH OF A CONNECTION TO MY ANCESTORS. BECAUSE MY TRIBE HAS BEEN LIVING ON THIS AREA FOR ABOUT, 15,000 YEARS. THAT MEANS MY ANCESTORS HAVE BEEN CULTURAL STEWARDS OF THE SALMON. THEY HAVE BEEN MANAGING THE SALMON. SO ME AND MY GRANDKIDS WOULD HAVE A SOURCE OF FOOD TO EAT. BE ABLE TO LIVE HEALTHY LIVES. THAT WAS TAKEN AWAY IN A SINGLE DAY. LEGISLATION IN THE AREA, IN OREGON. LED TO THE FISH KILL ON THE KLAMATH RIVER, LARGEST SALMON KILL ON THE WEST COAST IN HISTORY. WE NEVER REALLY RECOVERED FROM THIS. I MEAN EVEN KIDS NOW WHO DIDN'T GROW UP WITH THE TRAGEDY. SO, STILL GET PARANOID EACH YEAR THAT SOMETHING SIMILAR WILL HAPPEN. TO HAVE, ALL OF THESE CULTURAL TIES TO MY ANCESTOR, DEAD, AND THIS GENERATION OF FISH. WHOSE ANCESTORS WHO GREW UP WITH MY ANCESTORS AND KNEW THEM. IT'S, IT'S, REALLY HARD TO EXPRESS HOW --SADDENING THIS WAS FOR ME. AS SOME ONE WHO -- WHEN WE CATCH A FISH, WE SAY A PRAYER FOR EACH FISH. END OF THE DAY MY TRIBE ARE PRAYER PEOPLE. SO WE HOLD LIKE WHAT WE, OUR THOUGHTS VERY SACRED. AND --

EVERY TIME I CATCH A SALMON I PRAY FOR THAT FISH. HOW DO YOU PRAY FOR EVERY ONE OF THE FISH. HOW CAN YOU TELL THEM, WHAT HAPPENED TO THEM WAS RIGHT. YOU CAT. AND, IT IS REALLY HARD, RIGHT, FOR A 7-YEAR-OLD TO UNDERSTAND ALL OF THE SOCIAL, POLITICAL ISSUES OF THE TIME. BUT I STILL WAS ABLE TO UNDERSTAND THAT -- SOME ONE MADE A DECISION --WHEN IT CALL TO POLICY WHO DIDN'T GROW UP WITH THE SALMON. AROUND GREED. AND, I AM THE ONE WHO PAID FOR IT. THE SALMON ARE THE ONE WHO PAID FOR IT. AND THE RIVER. NEXT SLIDE. AND, THE SALMON POPULATION CONTINUED TO DECLINE ON MY RIVER. THIS WAS MY FISHING DOCK THAT, ME AND MY DAD BUILT BY HAND IN 2014 ON THE LEFT. AND THEN THIS IS A PICTURE OF IT ON THE RIGHT IN 2021. IT'S NO LONGER USABLE. I DON'T EVEN THINK IT IS THERE THIS YEAR AT ALL. I THINK IT GOT COMPLETELY DESTROYED. BUT THE SALMON FISHING HAS BEEN SO BAD THAT WHEN MY LIFE USED TO, REVOLVE AROUND THIS --THIS TRADITION, NOW IT'S -- NOT AVAILABLE IN MY LIFE PRETTY MUCH AT ALL. AND EVEN WHEN IT IS, IT IS VERY SCARCE. IT IS LIKE, THERE MIGHT BE ONE OR TWO GOOD DAYS OF FISHING. IF YOU MISS IT, IT IS GONE. AND, WITH THAT, WE LOSE, NOT ONLY --

OUR FOOD SOURCE. AND WITH THAT, A LOT OF, HEALTH ISSUES,

COME. WE LOSE ATABILITY TO PASS DOWN STORIES. I GOT STORIES

AND A LOT OF TIME WITH FAMILY WHEN WE WERE ON THE BOATS.

WHEN WE WERE OUT HERE FISHING. BUT WHEN WE CAN'T, MAKE ANY
INCOME FROM THAT, THEN WE HAVE TO HAVE JOBS. THERE IS NOT A

LOT OF JOBS ON THE RESERVATION. THAT TAKES US AWAY FROM THE
HOME. THAT MEANS LESS TIME WITH FAMILY IS SPENT. ALL OF
THESE OTHER LITTLE CULTURAL THINGS I WAS TAUGHT, GET

DIMINISHED OVER TIME. THESE ARE MR. RECENT PHOTOS. THERE IS
DEAD SALMON FRY IN THE SPRINGTIME YOU CAN SEE IN THE WATER
BEFORE THEY GET A CHANCE TO GO OUT TO THE OCEAN. THERE IS
BLUE-GREEN ALGAE, CAUTION SIGNS AROUND THE RIVER BECAUSE OF
THE DAMS CAUSING BLUE-GREEN ALGAE THAT IS TOXIC FOR US TO
TOUCH. SO I GREW UP SWIMMING IN THE RIVER. BEING AROUND IT.

BUT --

NOW, YOU ARE, NOT SUPPOSED TO LET YOUR KIDS OR DOGS TOUCH THE WATER IT CAN MAKE THEM SICK.

IF THEY DO, THEY HAVE TO WASH OFF. SO, REALLY -MY COUSINS YOUNGER THAN ME NOW WILL NOT GET THE EXPERIENCE
I DID GROWING UP. MY FAMILY DID FOR THOUSANDS OF YEARS,
PREVIOUSLY. NEXT SLIDE. HERE ARE STATISTICS ABOUT THE
SALMON FISHING TOO. THIS WAS A STUDY DONE IN 2005. KEEP
THAT IN MIND. THE SALMON POPULATION HAS GONE DOWN SINCE

THEN. SO I THINK THE NUMBERS ARE EVEN MORE DISPARAGING NOW. BUT TRADITIONALLY, THE PEOPLE IN THE TRIBE, EAT, 450 POUND OF SALMON PER PERSON PER YEAR. THAT IS A LOT OF SALMON. WHEN THE STUDY WAS DONE IN 2005, IT'S EVEN LESS THAN THAT. MY UNCLE HAS A BEAUTIFUL QUOTE ABOUT THIS TOO. BECAUSE --ONE IT IS NOT LIKE WE CAN JUST BUY SALMON IN THE GROCERY STORE. ONE, BECAUSE I AM PICKY ABOUT SALMON NOW. I AM A SALMON CONNOISSEUR, SO, A LOT OF GROCERY STORE SALMON TASTES PRETTY GROSS TO ME HONESTLY. THERE IS NOTHING LIKE FRESH SALMON. BUT TOO, IT IS NOT ONLY ABOUT -- CATCHING THE SALMON EATING IT. MY UNCLE SAYS, THIS IS A LESSON FROM HIS GRANDMOTHER THAT HE GOT. BUT THE BEST TASTING SALMON IS THE ONE THAT YOU GIVE AWAY. WE GIVE SALMON TO THOSE WHO ARE DISABLED, ELDERS, AREN'T ABLE TO FISH, FIRST.

AND SEEING THEM ENJOY, A FRESH SALMON, AND BEING ABLE TO HAVE THAT CONNECTION --

TO HEALTH, THEIR ANCESTORS AND AWFUL THE GOOD THINGS THAT SALMON BRINGS, THE GOOD ENERGY THAT WE PUT INTO IT, WHEN WE CATCH IT. PRAY FOR THE SALMON AND BRING IT TO THEM. IS A FEELING OF FULLNESS NOT IN THE STOMACH BUT IN THE SOUL THAT CAN'T BE REPLACED. NEXT SLIDE. AND BECAUSE OF THIS, I STARTED GOING TO PROTESTS FROM A YOUNG AGE. WHEN I WAS --

I THINK IN HIGH SCHOOL. I GOT ON THE -- THE BUS, WENT ALL THE WAY DOWN TO SACRAMENTO FROM THE RESERVATION WHICH IS REALLY FAR FOR ME. SEVERAL HOURS AWAY ON THIS BUS TO, TO PROTEST AT THE SENATE BUILDING. ASKING FOR -- FOR EMERGENCY FLOWS TO BE RELEASED SO WE WOULDN'T HAVE ANOTHER SALMON KILL. AND THIS -- AFTER I HAD DONE THAT. KIND OF CONTINUED. BECAUSE FOR ME I WAS LIKE, IN HIGH SCHOOL, WAS ALONE. THE FIRST TIME I CAME FACE TO FACE TO PEOPLE WITH REALLY GOOD SCARY GUNS. THAT WERE POINTED TOWARDS ME. JUST BECAUSE -- I WANTED MY SALMON NOT TO DIE. THAT'S ALL WE WERE ASKING FOR. WE ASKED, I REMEMBER THIS YEAR FOR A PERMIT TO PROTEST. AND WE WEREN'T GIVEN THE PERMIT. AND THEN, YOU KNOW, THE LEADERS OF WHO ORGANIZED THIS KIND OF, SAID, SCREW IT, WE ARE GOING TO DO IT ANYWAY. FOR US, SALMON FISHING IS A LIFE OR DEATH SITUATION. A PROPHECY, THE SALMON GO AWAY. WE AS INDIGENOUS PEOPLE GO AWAY TOO. IT IS HARD FOR ME TO TALK ABOUT. AN ISSUE THAT I HAVE TO FIGHT WITH EVERY SINGLE DAY. BUT I WENT TO THAT PROTEST. AND --GOT TO SEE THE CHANGE THAT REALLY HAPPENED. GOT TO SEE --

WATERS BE RELEASED. AND THEN --

I JUST KEPT DOING IT. ANY TIME A CHANCE TO. TALK ABOUT MY EXPERIENCE. AND SUPPORT --

THESE FLOWS BEING RELEASED FOR THE SALMON. I WAS THERE. AND THEN --

WHEN I WENT TO COLLEGE, AND LEARNED ABOUT DISPARITIES FOR INDIGENOUS PEOPLE AROUND THE WORLD WHERE I STARTED MAKING CONNECTION AS BUT MY RIVER AND OTHER PEOPLE'S STRUGGLES. NEXT SLIDE. THAT MADE ME REALIZE IF I WANT TO SAVE MY RIVER, I HAVE TO SUPPORT OTHER PEOPLE'S RIVERS AND WATER SOURCES TOO. BECAUSE, ALL OF THE WALTER SOURCES ARE CONNECTED. IT'S NOT LIKE THE, WATER STOPPED ON THE BORDERLINE. THERE IS DIFFERENT POLICY HERE, LET ME ACT DIFFERENTLY. NO, THE WATER IS NOT GOING TO CARE ABOUT THE BORDER LINES OR THE DIFFERENCES IN POLICY IN EACH STATE. IT IS ALL CONNECTED. TO BE A GOOD STEWARD TO MY RIVER, I HAVE TO BE A GOOD STEWARD TO OTHER PEOPLE'S RIVERS, LAND, WATERWAYS AS WELL. THAT'S EVENTUALLY BROUGHT ME TO CATCHING A RIDE TO STANDING ROCK. I GOT A RIDE WITH PEOPLE I DIDN'T KNOW. ALTHOUGH, STANDING ROCK, AND I GOT LEFT -- THERE, ACTUALLY. GOT TO BE THERE, ALL OF THESE NATIVES. A MININATIVE CITY. DIFFERENT TRIBES. TALKING ABOUT THEIR WATER ISSUES. IT OPENED UP MY PERSPECTIVE.

I WAS THERE TO FIGHT FOR, THE WATER, UP THERE IN THE DAKOTAS. I HOPED PEOPLE WOULD COME AND FIGHT FOR ME AND MY

RIVERS AND SO ON. WHEN I WAS AT STANDING ROCK, IT HAD ME QUESTIONING MYSELF. SO, WE HAVE THIS THING WE WANT. WE ARE ASKING ALL OF THESE PEOPLE FOR --

FOR THIS WATER, FOR THIS, PROTECTION, AND IT IS NOT OUT OF SELFISH REASONS. OUT OF A -- NECESSITY TO SURVIVE. AND FOR US TO LIVE BETTER LIVES INSTEAD OF GIVING PRETTY MUCH GIVING GRIEF TO CORPORATION WHOSE MAKE PROFIT, WHICH A LOT OF THE PEOPLE, WOULDN'T EVEN SEE IN THE AREA. WHO IS HEARING THE DEMANDS. WHAT IS HAPPENING AFTER THEY HEAR WHAT WE WANT. AND HOW DOES THE DECISION MAKING PROCESS HAPPEN SO WE GET WHAT WE ARE ASKING FOR OR DON'T GET WHAT WE ARE ASKING FOR. SOUNDED LIKE I WAS YELLING INTO THE VOID. SOME TIMES IT WORKED. SOME TIMES IT DIDN'T. I WANTED TO KNOW WHY IT DIDN'T WORK. I APLAYED FOR A SCHOLARSHIP TO GO TO KAOES DECEMBER. SO, NEXT SLIDE. SO I A SCHOLARSHIP TO GO TO THE NATIVE AMERICAN POLITICAL LEADERSHIP PROGRAM. IN WASHINGTON, D.C. FOR A TERM. I STUDIED AT GEORGE WASHINGTON UNIVERSITY, AND GOT MY POLITICAL SCIENCE MINOR. THIS WAS REALLY SPECIAL TO ME. THIS WAS A WORLD THAT NONE OF MY FAMILY WAS OPEN TO BEFORE. COLLEGE WAS A NEW FOR MY NATIVE FAMILY. I AMOUNT FIRST PERSON WITH A FOUR-YEAR DEGREE. DEFINITELY FIRST PERSON WITH A MASTER'S WITH MY NATIVE

SIDE. BUT THE, THE, POLICY SIDE, I DIDN'T KNOW ANY POLITICIANS AT THE TIME. SO --

WORKING IN THE SENATE COMMITTEE ON INDIAN AFFAIRS AND SEEING HOW POLICY WENT BY, WHAT PEOPLE ARE LOOKING FOR, WHAT CHANGES PEOPLE'S MIND ON WHAT THEY PAY ATTENTION TO, WHAT THEY DON'T PAY ATTENTION TO, WHAT THEY SIGN. PRETTY MUCH HOW THE LEGISLATION, LEX, PROCESS WORKS IN THE UNITED STATES. REALLY GAVE ME MORE INDEPTH UNDERSTANDING WHICH WE DIDN'T HAVE TIME TO GO INTO. ON WHAT I NEEDED TO DO TO GET MY VOICE ACROSSLE I AM VERY PRIVILEGED. I HONESTLY APPLIED TO THE FELLOWSHIP. WHY WOULD THEY SEND A CIVIL ENGINEER TO D.C. TO STUDY POLITICS. WHERE I GOT TO MEET THE LOVELY BRENDA AS WELL. WHICH I AM VERY GRATEFUL FOR. NEXT SLIDE. NEXT SLIDE. AFTER BEING IN D.C. I WENT TO PROTESTS, AND RALLIES, TALKED TO PEOPLE THAT I LEARNED, IN THESE DIFFERENT AREAS, BUT I ALSO, CONTINUED MY ENGINEERING DEGREE. I STARTED TO GO TO CITY COUNCIL MEETINGS AND TO TALK TO LEGISLATORS. USING WORDS THAT I LEARNED IN D.C. AND KIND OF --

LEARNING WHAT THEY WANT TO HEAR AND EXPRESSING THAT. OR
FORMATTING MY STORY IN A WAY THAT WAS ACCEPTABLE TO
POLITICIANS. AND, THAT MADE ME BE ABLE TO MEET WITH A LOT

MORE POLITICIAN WHOSE ACTUALLY LISTENED TO ME. IT WAS

STRANGE BECAUSE, FOR ME ONE THEY REALLY LIKED THE

ENGINEERING SIDE. HAVING TECHNICAL KNOWLEDGE OF ENGINEERING

WAS BENEFICIAL TALKING ABOUT WATER ISSUES, I COULD SAY NOT

ONLY ARE THESE FOR EXAMPLE, PIPELINES ARE BAD FOR OUR

CULTURE AND TRIBAL NATIONS, BUT I COULD SAY THEY'RE BAD

INFRASTRUCTURE PROBLEMS FOR THIS, THIS REASON. AND SO -
IT'S --

IT'S HARD FOR ME TO EXPRESS THIS BECAUSE -WHAT I WAS ASKING FOR DIDN'T CHANGE. BUT HOW I SAID IT. AND
THOSE WHO SAW -- THOSE IN POWER WHO SAW ME, THEIR
PERSPECTIVES OF ME CHANGED. BECAUSE I WAS GOING TO COLLEGE.
BECAUSE I AM AN EDUCATED NATIVE. AND BECAUSE I SPENT TIME
IN D.C. WHICH, TO ME DOESN'T FEEL RIGHT BECAUSE A LOT OF MY
COUSINS DON'T HAVE THE SAME OPPORTUNITIES, IF YOU -THE NUMBER OF NATIVE AMERICAN WOMEN IN, CIVIL ENGINEERING,
ROUNDED TO THE NEAREST TWO DIGITS, STILL ZERO. SO
FRUSTRATING TO ME WE DON'T HAVE THE OPPORTUNITIES TO BE IN
THESE SPAEUSZ. YET I AM LISTENING TOO, BECAUSE I DID ALL OF
THIS WORK, TO GET AWFUL THE DEGREES, GO ALL OF THESE
PLACES, AND BECAUSE OF THAT, I HAD TO LEAVE MY HOMELAND
TOO. RIGHT. SO, I, I TRIED TO GO BACK TO MY HOME AS MUCH AS

I CAN. I ALSO HAVE TO RECOGNIZE I AM MORE DISCONNECTED BECAUSE SOME PEOPLE ON THE RESERVATION BECAUSE THERE IS NO SCHOOLS ON THE ROSIER SRAGS FOR ME. I HAVE TO LEAVE HOME TO GET THE DEGREES. THEN NOT ON THE RESERVATION, A LOT OF PEOPLE DON'T RETURN TO THE RESERVATION AFTERWARDS. GET ALL OF THE FANCY JOB OFFERS IN THE CITY WHERE YOU DON'T HAVE TO DRIVE 2000 HOURS EACH WAY OR MORE, SOME TIMES A FULL DAY TO GET FOOD. OR DON'T HAVE TO STAY IN TRAILERS OR POOR HOUSING. AND IT'S, INSANE TO ME THAT I CAN BE IN THIS SPACE. THERE ARE TIMES I AM LISTENED TO. THOSE WHO ARE RIGHT NOW ARE LISTENING TO ME. BUT THERE ARE SO MANY ON THE RESERVATION, WHO AREN'T. WE ARE SAYING THE SAME THINGS. AND, MAYBE SOME OF THEM COULD SAY IT BETTER THAN I CAN. THEY DON'T JUST HAVE THE CHANCE. NEXT SLIDE. THE NEXT BIG CHANGE FOR ME WAS FISHING GAME COMMISSION ON THE SPRING CHINOOK DECISION. SO THIS IS WHERE, ENVIRONMENTAL JUSTICE REALLY STICKS IN MY MIND. THE REASON I WENT ON TO MY PH.D., THE FISH AND GAME COMMISSION IN CALIFORNIA, HAD THIS DECISION THEY WERE GOING TO MAKE, SPRING, FALL, CHINOOK FAMILY WERE DIFFERENT SPECIES. AND THIS IS IMPORTANT. AT THE MOMENT THEY WEREN'T CONSIDERED, SEPARATE SPECIES. CONSIDERED THE SAME. SLIGHTLY GENETICALLY DIVERSE, THE

SPRING SALMON COULD RE-EVOLVE FROM THE SPRING SALMON. NEW

GENETIC RESEARCH CAME OUT RECENTLY THAT SHOWED THEY ARE

GENETICALLY DISTINCT ENOUGH WHERE YOU CAN'T HAVE THE SPRING

SALMON AGAIN ONCE THEY GO AWE OR ONCE THEY BECOME EXTINCT.

AND THIS DECISION, FIRST CAME ABOUT FOR, A PETITION PUT IN

IN 2018. I HEARD ABOUT THIS. I WAS WORKING FOR SAFE

CALIFORNIA, SALMON. AND INDIGENOUS BACKGROUND

I KNOW THAT THE SPRING AND FALL CHINOOK SALMON HAVE

DIFFERENT WORDS IN YURUK IN OUR LANGUAGES WHICH IS REALLY

IMPORTANT. THERE ARE OTHER SPECIES OF FISH AND ANIMALS, WE

JUST KIND OF DIFFERENT SPECIES WE GROUP AS ONE WORD. BUT WE

MAKE A REALLY DISTINCT POINT TO SEPARATE THEM. AND EVERYONE

KNOWS IN TRIBES, SPRING AND FALL SAL MEN HAVE DIFFERENT

TASTE AND DIFFERENT BEHAVIORS. WE HAVE BEEN FISHING FOR

THEM ALL OUR LIVES AND ANCESTORS LIVES AS WELL. SO I HELPED

WITH MANY OTHER PEOPLE. A BUN.

OF INDIGENOUS FOLKS TO COME TO THE MEETING AND SPEAK ON THE ISSUE. MANY OF THEM SAID THE SAME THING ABOUT THEIR EXPERIENCES WITH SPRING, FALL SALMON AND INDIGENOUS KNOLLAGE BOUT IT. AND FORTUNATELY, THE FISH AND GAME COMMISSION DID DECIDE TO SUPPORT HAVING SPRING AND FALL SALMON, DIFFERENT SPECIES. A BIG WIN AND GREAT FOR SALMON

AND THE WATER. BUT WHEN THEY WERE MAKING THEIR DECISION, ON THIS, THEY SPECIFICALLY SAID WHEN THEY WERE WRAPPING UP THAT THEY CANNOT MAKE DECISIONS BASES -- ON ECOLOGICAL KNOWLEDGE. NOT ONE OF THE BULLET POINTS OF TASKS THEY CAN APPROVE DECISIONS ON. THIS MADE ME DISAPPOINTED, ESPECIALLY WHEN THE, KNOWLEDGE BACKS UP WHAT IS BEING TOLD WITH THE GENETICS AND SOMETHING WE HAVE KNOWN. JUST, SCIENCE IS CATCHING UP TO IT. I THINK ALL INDIGENOUS PEOPLE SPEAKING, MADE A DIFFERENCE. THOUGH NOT OFFICIALLY ALLOWED TO MAKE A DECISION BASED ON IT. THERE ARE MANY GOALS WHERE POLICY COULD BE SUPPORTED BY INDIGENOUS KNOWLEDGE IN CALIFORNIA, PRETTY MUCH EVERYWHERE. I HAVE TO HAVE SCOPE FOR MY PH.D., RIGHT. POLICY CAN BE SUPPORTED BY TEK AND TRADITIONAL KNOWLEDGE. WE NEED TO FIND THE HOLES AND HOW THEY'RE SUPPORTED. THE OTHER PART OF THIS TOO, IS ERICA, ONE OF, THE PEOPLE ON THE COMMISSION. SHE WAS RECENTLY ELECTED I KNOW HER THROUGH ACADEMIA, SHE ALSO WORKS ON SALMON ISSUES. AND SHE IS A WOMAN OF COLOR. AND, HAVING HER BE LIKE THE ONLY WOMAN OF COLOR, PERSON OF COLOR ON THE BOARD. HAVING THE CONNICKTION TO ME THROUGH ACADEMIA WAS IMPORTANT. SHE LET ME KNOW, PEOPLE WEREN'T SHOWING UP TO THE COMMISSION HEARING, TO THE HEARINGS. I WAS ABLE TO GET

PEOPLE TO COME. BECAUSE, SHE WANTED TO KNOW MORE ABOUT THE ISSUE. AND, AND --

I DO THINK THAT MADE A SIGNIFICANT CHANGE ON HOW THIS OUTCOME WENT. BUT, RIGHT, IF SHE IS A PERSON OF COLOR WAS ON THAT BOARD. THEN I WOULDN'T HAVE KNOWN. I WANT HAVE BEEN ABLE TO BRING MY FRIEND, COLLEAGUES AND ALSO THOSE AT STANFORD WHO COULD SPEAK ON TECHNICAL BACKGROUND. TO THIS MEETING. SO ONE MORE THING, WHY DIVERSITY MATTERS. OTHERWISE, WHO KNOWS WHAT MAY HAVE HAPPENED WITH THE DECISION. A LOT OF THE BOARDS. AND, COMMISSIONS ARE, MAJORITY WHITE. NEXT SLIDE. SO THAT LED ME TO MY PH.D., THAT I AM JUST STARTING MY FIRST WEEK ON. GETTING THROUGH ORIENTATION WEEK THIS WEEK. AND I AM A BIT -- A BIT ALL OVER THE PLACE WITH THAT TOO FOR ME I WANTED TO STUDY THE INTEGRATION, I WILL STUDY THE INTEGRATION OF INDIGENOUS KNOWLEDGE IN THE CALIFORNIA WATER POLICY TO ESTABLISH PRACTICAL CLIMATE CHANGE POLICY. WE NEED INDIGENOUS INPUT. SO BECAUSE OF THE ISSUE LAST YEAR WITH THE FISH. WITH THE SPRING SALMON DECISION, IT PUSHED ME INTO THE PH.D.. BECAUSE I CAN GO INTO THIS WORK FORCE AS THE, CIVIL ENGINEER. ACTUALLY HAVING A PH.D. AS CIVIL ENJAW NEAR IS A BIT DETRIMENTAL. I COULD BE MAKING WAY MORE MONEY

INITIALLY. BUT FOR ME THIS IS AN IMPORTANT ISSUE. THAT I REALLY WANT TO LOOK INTO. BECAUSE --

ONE I WILL, IF YOU EVER WORKED IN POLITICS, ESPECIALLY STATE POLITICS YOU MIGHT KNOW THAT --

STATE BOARDS AND POLITICAL AGENCIES IN GENERAL DON'T TACK
TO EACH OTHER VERY WELL. THIS GIVES ME A CHANCE TO LOOK AT
THE SYSTEM FROM A HOLISTIC VIEW WHERE IF THE ORGANIZATIONS
THEMSELVES ARE DOING THE WORK THEY HAVE A LIMITED SCOPE ON
WHAT THEY'RE DOING. ALSO GIVES ME A CHANCE TO DO THIS WORK
WITHOUT -- WITHOUT THE DIFFERENT, DEPARTMENTS, TRIBAL
LIAISONS GETTING FUNDING TO DO THE WORKP MY HOPIZE CAN
POINT OUT ALL OF THESE -- GOALS OR AREAS WHERE -INDIGENOUS KNOWLEDGE CAN BE INPUT INTO THE SYSTEMS MAKING
POLICY DECISIONS. AND, THEN THE TRIBAL LIAISONS FOR THE
DIFFERENT ORGANIZATIONS, CAN POINT TO MY RESEARCH AS AN
ACADEMIC AND SAY --

THIS IS WHAT, WE HAVE, WHAT HAS BEEN TESTED THIS IS WHAT

CAN BE DONE TO IMPROVE OUR AGENCY RELATIONSHIP WITH TRIBE,

TRIBAL INPUT. AND HOPEFULLY, MY HOPE IS IT WILL PASS FASTER

BECAUSE I REALLY WANT TO DO WORK IN RESEARCH THAT IS GOING

TO LEAD TO CHANGE AND OUTCOME, NOT JUST BE THEORETICAL

FOREVER. NEXT SLIDE. SO WHO IS CLIMATE CHANGE FOR? NOW I AM

KIND OF GETTING AWAY FROM MY PERSONAL STORY AND GETTING INTO THE IDEAS OF INDIGENOUS PEOPLE AND CLIMATE JUSTICE AS A WHOLE. (READING OUOTE FROM POWERPOINT) THROUGH LAWS, REGULATIONS AND POLICIES. AND THERE IS NO ENVIRONMENTAL JUSTICE, WITHOUT RACIAL JUSTICE. AND, THERE IS NO ENVIRONMENTAL JUSTICE WITHOUT, CONSIDERING HOW RACE, NATIONAL ORIGIN, INCOME ABILITY, IMPACTS OPPORTUNITY, AND TREATMENT WHEN IT COMES TO THE ENFORCEMENT -- WITH REGARDS TO ENVIRONMENTAL JUSTICE. NEXT SLIDE. ONE OF THE THINGS I REALLY TRIED TO PRESS, TRADITIONAL ECONOMICAL KNOWLEDGE. PRETTY MUCH WHAT WE ARE TALKING ABOUT, TALKING ABOUT THE SPRING SALMON DECISION. THAT WAS TEK. AND TEK IS -- I WON'T BOTHER READING THIS. BUT YOU CAN IF YOU WANT. PRETTY MUCH EVOLVING, KNOWLEDGE BASE OF INDIGENOUS PEOPLE PASSED DOWN FROM THOUSAND OF YEARS HAVING A CLOSE RELATIONSHIP WITH THE LAND AND WATER. AND THIS INCLUDE, MANAGE PRACTICES AND SCIENCE. WHICH IS, RELATIONSHIPS, PLANTS, ANIMALS, PHENOMENONS, LANDSCAPES. LIFE WAYS, ETC. KIND OF THE HARD SCIENCE OF IT. SOMETHING THAT I DON'T THINK IS LOOKED INTO AS MUCH. SHOULD BE IS VALUES AND LEADERSHIP AROUND TEK. FOR EXAMPLE, DIVERSITY OF INPUTS. WHEN WE SAW THE LAST SLIDE. GO AHEAD, GO TO THE LAST SLIDE. PREVIOUS ONE. BACK AGAIN.

SORRY. BACK ONE MORE. GOT IT. DIVERSITY OF INPUTS. IF YOU LOOK AT THE SENATE. AND THE HOUSE RIGHT NOW. WE DON'T HAVE A LOT OF DIVERSITY OF INPUTS. MAINLY OVER REPRESENTATIVE OF OLD WHITE MEN, RIGHT. AND -- AND, FOR INDIGENOUS PEOPLE FOR A LOT OF TRIBES WHEN THEY HAVE COUNCILS, IT, WAS IMPORTANT TO HAVE A DIVERSITY OF -- OF PEOPLE AT THE TABLE. THIS INCLUDES, YOUTH, ELDERS, AND THOSE FROM DIFFERENT BACKGROUNDS, INCLUDING --

GENDER AND, AND --

OR, OR, GENDER ORIENTATION, SEXUAL ORIENTATION. SO HAVING
THESE DIFFERENT BACKGROUND, CREATES MORE DIVERSITY AND
OPINIONS AND CAN COME UP WITH BETTER SOLUTIONS THAN IF YOU
HAVE SOME ONE WITH ALL OF THE SAME BACKGROUND, IN A ROOM
MAKING THESE DECISIONS FOR EVERYONE. WE HAVE FORMS OF
CONFLICT RESOLUTION IN THE TRIBES. WE HAVE DIFFERENT
PERSPECTIVES, PLANTS, ANIMALS, MY TRIBE, WE HAVE A BUNCH OF
COUNTING SYSTEMS. SO, SOMETHING I WOULD COUNT, SOMETHING
THAT IS ROUND --

LIKE THE SODA BOTTLE CAP. DIFFERENT THAN I WOULD COUNT THIS FLAT THING. THERE WOULD BE TWO COUNTING SYSTEMS FOR THOSE.

BUT THE COUNTING SYSTEM FOR SALMON AND PEOPLE ARE THE SAME.

SO THAT JUST KIND OF GIVES INSIGHT ON HOW IMPORTANT THE

SALMON ARE AND HOW WE KID THEM. SAME AS REDWOOD TREES. SO FOR US HAVING THAT COUNTING SYSTEM. HAVING THAT PERSPECTIVE THAT -- THAT WE ARE NOT ABOVE SALMON, THAT WE ARE ON EQUAL PLAYING GROUNDS. IF THERE IS NO SALMON, THEN THERE IS NO US. HELPS SHIFT THE WAY WE, WOULD MAKE, POTENTIAL LEGISLATION ABOUT THE TOPICS. WE HAVE -- WAYS WE, WE DO NEGOTIATIONS AND OUR MIND SET IS LONGER THAN IN POLICY. SOME POLICY WE HAVE IDEAS, REALLY FOLKS ARE ON ECONOMICS, AND KIND OF WHAT WE CAN AFFORD, AND, AND, WE TEND TO SAY THAT WE CAN'T -- MAKE POLICY THAT IS GOING TO AFFECT THAT MANY FUTURE JEN RATIONS BECAUSE WE DON'T KNOW WHAT THEY'RE GOING TO WANT. AND I FIND THIS -- A BIT SILLY, BECAUSE WE KNOW, THEY'RE GOING TO WANT FOOD. (GENERATIONS) WE KNOW THEY WANT WATER AND THEY WANT CLEAN AIR FOR EXAMPLE. AND THAT WE SHOULD, START THINKING ABOUT SEVERAL GENERATION AS HEAD OF TIME. BECAUSE RIGHT NOW IN AMERICAN CONSCIOUSNESS, AROUND POLITICS IT'S DIFFICULT FOR PEOPLE TO THINK KIDS, GRANDKIDS MAKING THE DECISIONS. INDIGENOUS OF PEOPLE ARE THINKING SEVEN GENERATIONS DOWN THE LINE. MANY, MANY, MANY MORE GENERATIONS HAVING THE WIDER MIND SET WOULD BE BEN FISH TO ALL OF US WHEN IT COMES TO THIS TIME OF CLIMATE CHANGE.

BECAUSE THESE AREN'T GOING TO BE, USE SOLVED IN ANY OF OUR LIFE TIMES. FOR ME AS AN ENGINEER, YOU CAN SEE THIS WITH THE DAMS, ONE REASON WE ARE HAVING THE SALMONNER USE BECAUSE OF THE DAMS ON THE RIVER. IN ADDITION TO ANY OTHER. FOR EXAMPLE WHEN YOU ARE DESIGNING A DAM, A DESIGN LIFE FROM 50 TO 100-SOMETHING YEARS. ONE THING IS WE DON'T, DESIGN HOW TO TACK OUT THE DAM WHEN DESIGNING THE DAM ITSELF. WE ASSUME THAT, FUTURE ENGINEERS WILL HAVE, BETTER TECHNOLOGY AND ARE SMARTER AND THEY WILL FIGURE IT OUT THEMSELVES, SO WE DON'T EVEN BOTHER. FOR ME A BIT RIDICULOUS. I UNDERSTAND IT IN A SENSE. AWFUL THE ENGINEERS ARE TRYING TO FIGURE HOW TO TAKE OUT THE DAMS, NOT LIKE WE HAVE CRAZY LASERS TO DISINTEGRATE THEM. IT IS STILL A STRUGGLE FOR US. A WAY TO TACK OUT THE DAM SAFELY WAS DESIGNED WHEN MAKING THE DAM ITSELF, IT WOULD HAVE, GONE A LOT SMOOTHER. BUT -- WE DON'T HAVE THAT LONG TERM PERSPECTIVE. ALL OF THE ENGINEER WHO WOULD HAVE DESIGNED, THE DESIGN LIFE, THEY'RE RETIRED OR DEAD BY THE TIME THE DAM IS READY TO BE TAKEN OUT. NOT LIKE THEY HAVE AN INVESTMENT IN IT. TEK IS, HARD SCIENCES AND MANAGE THE STYLES. THAT WOULD BE BENEFICIAL WHEN IT COMES TO CLIMATE CHANGE. AND BROUGHT TO THE TABLE, FOREFRONT, MAKING

DECISION AS BUT THE FUTURE. NEXT SLIDE. NATIVES ARE EXTRA VULNERABLE TO CLIMATE CHANGE. PROTECTORS. AND, ANECKED BY THE EFFECTS OF CLIMATE CHANGE. AND --THIS IS IMPORTANT, BECAUSE, THERE IS A BOUT, 370 MILLION PEOPLE WHO ARE INDIGENOUS AROUND THE WORLD A. BUT 5% OF THE WORLD'S POPULATION. NEARLY, 2,000 COMMUNITIES, 87 COUNTRIES. AREAS WHERE, 27 MILLION PEOPLE WILL BE ANECKED BY SEA LEVEL RISE. THE EFFECT OF CLIMATE CHANGE. AND THERE IS NOT A PART OF THE WORLD WHERE COASTAL NATIVE PEOPLE DO NOT LIVE. I AM ONE OF THEM. I AM A COASTAL AND NATIVE PERSON. YOU CAN SEE SOME OF MY FRIEND. THE PACIFICS HAVE SEEN BURIAL GROUND, THEY HAVE HAD, FOR CENTURIES. START TO GO UNDERWATERMENT THEY CAN'T VISIT ANCESTORS GRAVES ANY MORE. BECAUSE THEY'RE FLOODING. THERE IS DEFORESTING, MANAGE, 24% OF THE WORLD'S FORESTS. AND BIODIVERSITY. AND INDIGENOUS PEOPLE PROTECT 80% OF THE DIVERSITY. DESPITE BEING VULNERABLE. WE ARE DOING HEAVY LIFTING WORK WHEN IT COMES TO PROTECTING THE ENVIRONMENT. NEXT SLIDE. SO IF TECH IS ALL, DOING THESE GREAT THINGS, INDIGENOUS PEOPLE ARE COOL LEADERS AT ARE, CAN POTENTIALLY HELP US, WHY AREN'T WE USING IT AND GIVING IT RIGHT NOW. NEXT SLIDE. I CAN'T GO THROUGH THE HISTORY OF AWFUL THE WRONG THINGS THE U.S. HAS

DONE. AND THE SYSTEMATIC ISSUES. BUT, ONE OF THE THINGS SURPRISING TO ME IS, ESPECIALLY, BECAUSE I DIDN'T LEARN IT UNTIL COLLEGE WAS, IT FEELS LIKE ENVIRONMENTALISM WAS INITIALLY CREATED FOR WHITE PEOPLE. ENVIRONMENTALISM IS AT THE MOST BASIC ADVOCATING FOR PROTECTION OF OUR ENVIRONMENT. BUT THE SIERRA CLUB, FOUNDER WAS KNOWN AS THE FOUNDER OF THE NATIONAL PARKS, OR FATHER OF THE NATIONAL PARK SYSTEM. SAID HORRIBLE THINGS JUST TO MAKE CLEAR THE NATIONAL PARK SYSTEM AND, SIERRA CLUB WAS INITIALLY UPPER-CLASS, WHITE MAN'S EXPLORERS CLUB AND THEY'RE IN THE WILDERNESS IN ORDER FOR THEM WHO COULD AFFORD TO BE IN THE WILDERNESS. ABILITY TO ENJOY IT LONGER. WASN'T FOR OTHER PEOPLE. IT WAS FOR ONE GROUP. THE FOUNDER DESCRIBED AFRICAN-AMERICANS AS LAZY "SAMBOS" AN OFFENSIVE TERM. HE DESCRIBED, NATIVE AMERICANS AS DIRTY. PRESERVING NATURE FOR WHITE PEOPLE. AND HE WAS GOOD FRIENDS WITH THE DUDE NAMED FAIRFIELD OSBORNE. AND -- AND THEY -- FAIRFIELD WORKED TO CONSERVE NATURE AS WELL. ONE OF THE REASONS THEY WERE GOOD FRIENDS. HE WAS A WHITE SUPREMACIST. AND, OSBORNE, OSBORNE FOUNDED THE AMERICAN TO GENIC SOCIETY. -- EUGENIC SOCIETY. AND DID ALL OF THESE HORRIBLE THINGS. DIDN'T ALLOW WOMEN OR PEOPLE OF COLOR IN THEIR CLUB, IN THE SIERRAS CLUB. SO WE

REALLY, A LOT OF PEOPLE SUPPORT NATIONAL PARKS. I DO TOO.

THINK OF IT AS THIS GREAT THING THAT -- THAT PRESERVED THE

NATURE FOR, FOR EVERYONE TO ENJOY. THAT'S REALLY NOT HOW IT

STARTED. NOT HOW IT STARTED. AND THEE DOOR ROOSEVELT

HELPED. CONSERVATION PRESIDENT. DOUBLED THE NUMBER OF SIZE

OF PARKS IN THE SYSTEM. HOWEVER HE SAID THE FOLLOWING. NEXT

SLIDE. FOR ME THIS WAS DEVASTATING WHEN I LEARNED IT. I WAS

A KID. BECAUSE OF THE NATIONAL PARK SYSTEM, THE TEDDY BEAR.

TEDDY ROOSEVELT WAS MY FAVORITE PRESIDENT. THEN I FOUND OUT

ABOUT THIS. I FELT LIKE, OH, WAIT. THESE PEOPLE I WAS

TAUGHT TO LOOK UP TO IN SCHOOL HATE ME AS A PERSON BECAUSE

I AM NATIVE AMERICAN. AND NOTHING ELSE. JUST KNOWING THAT

IS --

KNOWING KIND OF, THAT'S KIND OF WHEN I STARTED TO BE

DISILLUSIONED WHAT I WAS BEING TOLD IN SCHOOL. WHICH IS

THIS WAS ELEMENTARY SCHOOL FOR ME. ABOUT TEDDY ROOSEVELT

MIGHT NOT HAVE BEEN THE TRUTH. LED TO A LOT OF CLARITY

LATER IN LIFE. THIS IS AN ISSUE. MY TRIBE DOES CULTURAL

BURNS. ONE OF THE REASONS WE HAVE INTENSE WILDFIRES IN

CALIFORNIA. MY TRIBE USED TO DO BURNS EACH YEAR. MANY OTHER

TRIBES HERE AS WELL. CREATED PRAYERIES BECAUSE OF THIS. HAD

WILDLIFE AND INSECTS ALONGSIDE OF US AND NOT IN SPITE OF

US. THE WILDERNESS WAS MANAGED TAKEN CARRY OF BY INDIGENOUS GROUPS. SOME GROUPS, LIKE EUROPEANERS WHO CAME, WERE DESTRUCTIVE TO IT, CAUSED HARM, DIDN'T MEAN EVERYONE WHO WAS HUMAN, WAS CAUSING THE SAME AMOUNT OF HARM. SO WE HAD A DIFFERENT RELATIONSHIP. AND WE REALLY WERE -- WORKING --IN, IN, ONE AND ONE WITH THE ENVIRONMENT. NOT DESPITE OF IT. AND SO WHEN WE WEREN'T BURNING THE BRUSH, THE LARGE WILDFIRES CAME UP. THERE WAS PILES OF BRUSH, YEARS AND YEARS. THE WILDFIRES WERE MUCH MORE DESTRUCTIVE. ONLY NOW STARTING TO GET BACK INTO THE BURNING PRACTICE AFTER HUNDRED OF YEARS, WILDFIRES ARE BECOMING MORE INTENSE. DUE TO CLIMATE CHANGE. THEN WE HAVE THE PRAYERIES ARE GOING AWAY, THAT A LOT OF BUG SPECIES ARE BECOMING ENDANGERED BECAUSE OF THIS. BECAUSE, YOU KNOW, WHITE FOLKS OR THE PEOPLE IN CHARGE. WERE THINKING THESE WERE NATURAL OCCURRING PRAYERIES. YET WE WERE THE ONES WHO CREATED PRAYERIES AND MAINTAINING THEM OVER THOUSANDS OF YEARS. WITHOUT US, THEY START TO DISAPPEAR. NATIVE PEOPLE WERE REMOVED, MANY MORE TIMES AFTER THIS. SO --

A LOT OF --

KIND OF THE HESITATION WHEN IT COMES TO INDIGENOUS

KNOWLEDGE NOW COMES FROM -- THIS, THIS PAST IDEA OF --

REMOVING NATIVES. SO, NATIVES WERE REMOVED BECAUSE WE WERE THOUGHT, WE WEREN'T USING THE LAND APPROPRIATELY. RIGHT, WE WEREN'T FARMING IT. AND THEREFORE, WE WEREN'T TAKING ADVANTAGE OF IT. AND, ANDREW JACKSON DESCRIBED NATIVES AS, CHILDREN IN NEED OF GUIDANCE. SAID THE REMOVAL PROCESS WAS BENEFICIAL TO US. GOVERNMENT REPORT -- IN SOUTHERN CALIFORNIA, EXPLAINED THAT, MANY CALIFORNIANS BELIEVED THAT, DESTINY HAD AWARDED CALIFORNIA TO THE AMERICANS TO DEVELOP. AND THAT IF THE INDIANS INTERFERED WITH PROGRESS THEY SHOULD BE PUSHED ASIDE. AND THIS IS IN 1852.

REMEMBER, MY TRIBE FIRST CONTACT IS IN 1851 IN CALIFORNIA. THIS MIND SET OF JUSTIFYING REMOVAL OF NATIVE AMERICANS.

THAT WERE CHILD LIKE AND THAT WERE KIND OF STUPID. HAS LED TO --

US NOT TAKING SERIOUSLY, WHEN IT COMES TO CLIMATE CHANGE.

WE ARE SEEN AS LESS WORTHY. WE DON'T KNOW WHAT WE ARE

TALKING ABOUT. THIS COMES FROM A LOT OF IMPLICIT BIAS,

MAYBE PEOPLE NOT UNDERSTANDING WHY THEY THINK THIS OR HAVE

PRECONCEPTIONS. BUT IT IS COMING FROM THIS PASSED DOWN

HISTORY OF JUSTIFICATION FOR REMOVAL OF NATIVE AMERICANS

FROM THE LAND. AND THEN YOU SEE THIS TODAY. HOPEFULLY NOT

AS MUCH TODAY. AT LEAST, PREVIOUSLY WITH NATIVES AND MEDIA

WHEN HEY HAVE TONTO SPEAK. YOU MAY KNOW TONTO SPEAK, PICTURES FROM PETER PAN ON THE BOTTOM. REALLY BAD CHARACTER PICTURES. CARICATURES. BUT REALLY KIND OF BROKEN LANGUAGE. ME, BROOK, YOU, DAH-DAH-DAH, BUFFALO. BROCKEN UP LANGUAGE. THIS ACTUALLY COMES FROM, IT COMES FROM, ALIENATING NATIVES. IT OTHERS THEM. A HARVARD STUDY, IMPLICIT BIAS. A MAJORITY OF AMERICANS, SEE, NATIVE AMERICANS AS FOREIGN, AND WHITE PEOPLE AS NATIVE. WHEN I TOOK THE TEST. LET THAT SINK IN. MOST AMERICANS IMPLICITLY THINK OF, NATIVE AMERICANS AS FOREIGN TO THE UNITED STATES. PARTIALLY BECAUSE OF HOW MEDIA PORTRAYED US. SPEAKING THIS BROKEN ENGLISH. AND YOU KNOW, NOT BEING HERE IN PRESENT DAY. WE CONTINUE TO BE HURT BY MEDIA POUR TRAILS AND HOW WE ARE SHOWN. THE FACT THAT THERE IS NOT VERY GOOD REPRESENTATION OF US IN MEDIA NOW TO CHANGE THE, NARRATIVE. HAVING ONE, TWO, THREE, TV SHOWS IS NOT ENOUGH TO CHANGE THE MAINSTREAM NARRATIVE OF HOW NATIVES ARE SEEN. NEXT SLIDE, THIS IS ALL TO SAY THAT IT IS NOT ENOUGH TO PUT MORE BIPOC IN POSITIONS OF LEADERSHIP. THE CURRENT SYSTEMS ARE BASED INSIST TELLS OF REPRESSION. WE NEED TO BE OPEN TO CHANGE AND MOVE FORWARD BY LOOKING BACK TO PREVIOUS, TO WHAT, WHAT HAS WORKED PREVIOUSLY FOR USES SUCH AS MODELS THAT WORKED FOR

INDIGENOUS PEOPLE. WE HAVEDONE THAT IN SOME CASES. LIKE THE FORMAT. THERE IS DIFFERENT FORMATS OF THE U.S. GOVERNMENT. INCLUDING THE SOAP RATION OF THE THREE POWERS, LEGISLATIVE BRANCHES OF GOVERNMENT. BASED ON THE CONFEDERACY, AGREEMENT BETWEEN MULTIPLE TRIBES ON THE EAST COAST. SO THERE HAVE BEEN MULTIPLE ATTEMPTS, PULLED FROM INDIGENOUS KNOWLEDGE IT HAS BEEN SUCCESSFUL. BUT BECAUSE IT IS NOT TALKED ABOUT, IN THE MAINSTREAM, OR ACKNOWLEDGED. VERY OFTEN. WE GIVE CREDIT TO WHITE FOLKS AS ALWAYS. CONTINUES TO HURT US, WHEN HAVING POWER. HAVING CONVERSATIONS WHY WE SHOULD BE LISTENED TO. DIVERSITY OPENS UP POSSIBILITIES THAT WERE NOT PREVIOUSLY AT THE TABLE. ESPECIALLY WHEN IT COMES TO CLIMATE CHANGE. SO, THIS AGAIN IS TO BRING UP THAT WE NEED, MULTIPLE PEOPLE TO TABLE, SO WE NOT ONLY NEED INDIGENOUS PEOPLE. WE NEED BLACK FOLK. PEOPLE WITH DIFFERENT SEXUAL ORIENTATIONS. GENDER IDENTITIES. WE NEED PEOPLE WITH DIFFERENT ABILL TEASE. A LOT OF, COULDN'T GET INTO THIS RIGHT NOW. (ABILITIES) A LOT OF OVERLAP BETWEEN DISABILITY JUSTICE AND JUSTICE FOR PEOPLE OF COLOR. AND, HOW THOSE LAWS ARE INTERTWINED. SO I RECOMMEND THAT, IF YOU HAVE TIME AFTER THIS, TO KIND OF LOOK INTO THAT. AND IF YOU, WANT SOME RECOMMENDATIONIZE CAN GIVE THOSE TO YOU OR PUT THEM ON MY

WEBSITE. R* ANOTHER EXAMPLE, I DENT SEE A LOT OF KIDS AT THE TABLE. WHEN TALKING TO GOVERNMENT AGENCIES EXPRESSING CONCERNS ABOUT CLIMATE CHANGE, I SEE SOME TIMES, KIDS PUT AT THE TABLE. WHEN THEY'RE, THEY'RE BEING LIKE OH, THAT'S CUTE. KEEP DOING WHAT YOU ARE DOING, AND SOME DAY YOU WILL BE LOOK AN OLD WHITE MAN CAN MAKE DECISIONS INSTEAD OF TAKING THEIR CONSIDERATIONS AS BEING IMPORTANT RIGHT NOW. BECAUSE FOR EXAMPLE, A LOT OF CHILDREN DON'T HAVE THE SAME --

THEY WEREN'T, THEY HAVEN'T GONE THROUGH THE SYSTEM YET.

THEY DON'T HAVE THE SAME --

KIND OF CAPS THAT ARE PUT ON THEIR IMAGINATION THAT, THAT,
HAVE BEEN PUT ON US. AFTER YEARS OF BEING YOU KNOW, KIND OF
PUSHED DOWN BY THE SYSTEM. SO HAVING KIDS AT THE TABLE GIVE
A LOT OF GOOD IDEAS AND ENERGY. REALLY GOING TO BE THEIR
FUTURE. SO THEY REALLY SHOULD HAVE INPUT ON WHAT IS GOING
ON WHEN IT COMES TO CLIMATE CHANGE AND THEIR FUTURES. YEAH,
WE KIND OF DO THE SAME THING. WHERE WE CONSIDER THEM DUMB.
BECAUSE THEY'RE YOUNG. THEY DON'T HAVE THEIR COLLEGE

INDIGENOUS IDEAS TO THE TABLE, BRINGING ALL OF THESE OTHER
BACKGROUNDS TO THE TABLE AS WELL. THAT'S A PART OF

INDIGENOUS KNOWLEDGE AND CLIMATE AND ENVIRONMENTAL JUSTICE.

NEXT SLIDE. SO, TO END, I WANT TO END WITH THE TWO QUOTES

FROM, FROM, OTHER, ACTIVISTS THAT, THAT -- I THINK ARE

DOING A REALLY GOOD JOB IN THE FIELD. THIS FIRST ONE IS

FROM, MS. RIVIERA. WHERE SHE SAYS --

I LEARNED ABOUT HER THROUGH THE UN. ONE OF THE SPACIZE AM REALLY HOPING TO PUSH TO CHANGE. IS MORE --

MORE PRESENCE OF INDIGENOUS PEOPLE IN THE U.N.. AND, AND PEOPLE IN D.C. WHO HAVE A LOT OF INSIGHT IN THE U.N.. FOR ME, AS PART OF A TRIBAL NATION, NOT BEING INVITED TO THE TABLE AS THE SAME POWER, AND JUST NOT HAVING LIKE DELEGATES, EACH YEAR FROM LIKE THE DIFFERENT TRIBES WHO ARE SEEN AS NATIONS WITHIN INSIDE THE UNITED STATES. AND INVITED TO THE TABLE AS EQUAL PARTNERS WITH THE OTHER NATIONS. KIND OF HONESTLY DISRESPECTFUL TO ME. DOES MAKE ME FEEL LIKE WE ARE PLAYING PRETEND NATIONS THEY DON'T SEE US AS A REAL, ENTITY. WHERE I FEEL LIKE IN THE UNITED STATES. IN THE UNITED NATIONS, WE SHOULD BE INVITED TO THE TABLE MORE AS INDIGENOUS NATIONS.

AND HAVE MORE OF OUR YOUTH COME TO SPEAK AT THESE MEETINGS.

NEXT SLIDE. THE NEXT IS FROM ELOY. THIS SLIDE ME BACK TO

THE SLIDE. BIODIVERSITY. FORESTS PROTECTED BY INDIGENOUS

PEOPLE. WE ARE ALREADY DOING THE WORK. WE JUST NEED, IF WE ARE GIVEN THE POWER AND TH-RT TO, DO MORE OF WHAT WE HAVE BEEN DOING -- WE COULD, COME TO THE SOLUTION IS A LOT QUICKER. (AUTHORITY) AGAIN, YET WE ARE OFTEN SEEN -- WE ARE, IF WE ARE SEEN AT ALL, THAT'S ONE OF THE OTHER ISSUES AS INDIGENOUS PEOPLE WE ARE OFTEN NOT SEEN. I MET MULTIPLE PEOPLE IN COLLEGES THAT DIDN'T KNOW THAT NATIVE AMERICANS WERE STILL ALIVE AT ALL. NONETHELESS THAT WE ARE DOING ALL OF THIS IMPORTANT WORK WHEN IT COMES TO CLIMATE CHANGE AND CLIMATE JUSTICE. WE ARE KIND OF SEEN AS A SECONDARY ENTITY IN THAT, LET THE GROWNUPS PLAY, THE PEOPLE WHO HAVE BEEN IN POLITICS FOREVER. AND THE PEOPLE WHO SCREWED THE WORLD INITIALLY. BUT, LET THEM FIGURE IT OUT INSTEAD OF BRINGING IN THE NEW ACTORS OR RATHER OLD ACTORS LIKE INDIGENOUS GROUPS TO HEAR OUR VOICE AND OPINION AND TAKE IT SERIOUSLY. AND FOR ME, I GUESS, YOU CAN GO TO THE LAST SLIDE. OUR NEXT SLIDE. I JUST WANT TO SAY THAT -- FOR ME, BEING BORN NATIVE AMERICAN, IS BEING BORN INHERENTLY POLITICAL, IT IS SO MUCH OF OUR LIVES AS INDIGENOUS PEOPLE IS WRAPPED UP IN POLITICS IN THE UNITED STATES. I CANNOT JUST LIVE IN MY TRIBE AND LIVE THE LIFE THAT MY ANCESTORS DID. I CAN'T GO FISHING AND HUNTING, AND, AND HAVE MY TRADITIONS. WITHOUT MY OTHER

COUSINS AND FAMILY MEMBERS GOING OFF THE RESERVATION, BEING BEAT UP BY FEDERAL AGENT AND LITERALLY JUST FIGHTING FOR ABILITY TO KEEP PRACTICING THE WAYS WE HAVE. I HAVE TO SPEND -- MUCH OF THE TIME, OFF MY RESERVATION. GOING TO THE UNIVERSITIES. LEARNING THESE OTHER FORMS OF POLICY AND LAW. IN ORDER TO HELP PROTECT THE WAY MY PEOPLE ARE LIVING. AND, AGAIN IT IS HARD. BECAUSE HOW AM I GOING TO BE THE ADVOCATE IF I AM NOT THERE, EXPERIENCING IT AND LIVING IT FIRSTHAND ALL OF THE TIME.

WE ARE REALLY AT A DISADVANTAGE HERE BECAUSE OF THAT. I
WISH MY LIFE DIDN'T HAVE TO BE IN HAEURB END LEAP
POLITICAL. BUT IT IS. AND I, I --

I REALLY ENJOY WHAT I AM DOING RIGHT NOW. I AM VALLEY

FORTUNATE FOR ALL I HAVE. BUT, I, THERE IS SO MUCH MR. TO

DO. AN, I AM SO THANKFUL THAT, THOSE OF YOU WHO ARE HERE

HAVE TAKEN THE TIME OUT OF YOUR DAY TO LISTEN TO ME A

LITTLE BIT. SO, THANK YOU.

YOU CAN ALSO, SUBSCRIBE TO NEWS ARTICLES LIKE -NATIVE NEWS TODAY. INDIAN COUNTRY TODAY. AND, AND -HIGH COUNTRY NEWS, ARE ALL REALLY GOOD PLACES TO HEAR FROM
INDIGENOUS VOICES AND KEEP UP ON INDIGENOUS ISSUES. AND
SO -- STAYING CURRENT, WITH WHAT IS HAPPENING IN THE AREA
IS REALLY IMPORTANT. UNDERSTANDING THE DISPARITIES IN THE
PAST, ALSO UNDERSTANDING CURRENT DAY PEOPLE WHO HAVE

WORKING FOR CORPORATIONS WHOSE INTEREST IS STILL IN THE
HARMFUL CATEGORY. AND SO, JUST TO BE CAREFUL ABOUT THAT.
BECAUSE THIS WILL BE THE JOBS THAT END UP PAYING THAT YOU
WILL HAVE CONSISTN'TLY. WHICH IS WHY I DIDN'T TPHEURBLLY GO
INTO ENVIRONMENTAL ENGINEERING AS GOING INTO SCHOOL. BUT
THE OTHER THING IS I WOULD SAY --

LIKE FOR ME PERSONALLY IT'S BEEN LIKE -- OH, GOSH, AGAIN, YOU CAN HONESTLY, YOU CAN PROBABLY GO INTO ANY SYSTEM AND FIND PLACES FOR IT TO CHANGE. AND WORK ON THAT. I COULD GIVE A WHOLE LECTURE ON THIS. TRYING TO SHORTEN WHAT I WANT TO SAY. I MEAN FOR EXAMPLE MY TRIBE HAS GIVEN -- OUR RIVER PERSONHOOD. MY TRIBE HAS RECOGNIZED OUR RIVER, LIKE SUCH AS CORPORATIONS HAVE IN THE U.S. AS HAVING PERSONHOOD THAT OPENS US UP TO SUE ON BEHALF OF THE RIVER IN THE FUTURE. SO, A LOT OF, PROGRESS IS MADE AS YOU PROBABLY KNOW BEING IN LAW SCHOOL THROUGH THE LAWSUITS. ON SPECIFIC ISSUES. SO I WOULD SAY --

AS LONG AS YOU ARE DOING WORK, YOU ENJOY, THAT YOU ARE NOT GOING TO GET KPA*UD IN, IN TEN YEARS. THAT'S PROBABLY THE MOST IMPORTANT PART. AND, THERE WILL BE TRIBES. AND INDIGENOUS PEOPLE THAT HAVE -- LAWSUITS THAT ARE IN, A

BUNCH OF DIFFERENT FIELDS. THEY'RE ULTIMATELY GOING TO BENEFIT THE ENVIRONMENT. I SAY DO WHAT YOU ARE PASSION THAT ABOUT. BE CAREFUL ABOUT GOING ENVIRONMENTAL LAW SPECIFICALLY. AND, CIVIL COURT, OPPORTUNITIES, EVEN ITCH NOT EVERY SINGLE DAY. KEEPING IN MIND THAT, THAT, EVERYONE WHO IS IN LAW SCHOOL, REALLY SHOULD HAVE A GOOD GRASP ON INDIAN LAW. BECAUSE IT IS VERY DIFFERENT AND A LOT OF LAW SCHOOLS DON'T GO AS MUCH INDEPTH INTO IT. IF YOU ARE IN D.C. IF YOU CAN GO WHEN TRIBES ARE SUING. A LOT OF OUR ISSUES GO TO FEDERAL COURT. A LOT OF SUPREME COURT JUSTICES WHO DIDN'T HAVE, A GOOD IDEA OF INDIAN LAW, BECAUSE OF THAT, EVEN IN THE SENATE IF YOU WORK AS A STAFFER IF ALL OF YOUR TIME IS TAKEN UP EXPLAINING BASICS UH NATIVE AMERICAN LAW INSTEAD OF THE ACTUAL, YOU ARE TRYING TO REPRESENT, IT IS PUTTING US AT A DISADVANTAGE. I WOULD SAY MAKING SURE YOUR COLLEAGUES AND LAW SCHOOL, TAKING NATIVE AMERICAN LAW SERIOUSLY JUST AS IMPORTANT AS WHAT YOUENED UP STUDYING IN THE LONG TERM. HOW YOU CAN CHANGE THE STRUCTURE OF YOUR SCHOOL AND YOUR SYSTEM. EVEN A LITTLE BUILT IN THAT SYSTEM. YEAH, NO PRESSURE. BUT LIKE -- IT WILL BE A LOT OF WORK REGARDLESS. YOU ARE IN LAW SCHOOL. YOU MIGHT AS DO A LITTLE MORE WORK TO GET YOUR OTHER CLASSMATES TO DO THIS STUFF

 GETTING INTO YOUR PH.D. PROGRAM. BECAUSE, WOW. I MEAN I

 JUST THINK YOU ARE, YOU ARE A MOVER AND A SHAKER. AND YOU,

 YOU ARE --

AN AWESOME COMING FROM AN AWESOME PERSPECTIVE. OH, MY GOSH.

AND --FOR I'M WONDERING, YOU MENTIONED -- THAT -
IN YOUR --

IN YOUR TRIBE. THAT YOU HAVE A WAY OF -OF REACHING A -- NOT A CONSENSUS, BUT -BUT, HEALING SITUATIONS AMONG, YOURSELVES, YOUR, YOUR ONE

JUST WONDERING IF YOU COULD SAY A LITTLE BIT MORE ABOUT

ANOTHER. WORKING OUT CONFLICT, CONFLICT RESOLUTION. AND I'M

THAT. BECAUSE THAT'S -- YEAH, WE, IN, IN -THIS TRADITION. THAT WE SIT IN OUR SANGHA, WE HAVE
SOMETHING CALLED BEGINNING ANEW THAT WE DO. AND -AND --

I'M JUST WONDERING IF THERE IS A SIMILARITY OR -OR SOMETHING.

>> I GUESS, WITH THE TIME WE HAVE LEFT. I WILL JUST GIVE YOU, ONE --

ONE MORE PIECE OF KNOWLEDGE THAT I HAVE PERSONALLY GROWING UP. AROUND THAT TOPIC. AFTER THAT I HAVE TO START CHARGING. NO, HA-HA. SO, LIKE, RIGHT I GREW UP WITH MY LANGUAGE. AND WE HAVE THIS THING CALLED SPEAKING IN LIKE YOUR, NATIVE MIND SET OR LIKE YOUR YUROK BRAIN AND THEN YOURING ENLUSH BRAIN. BECAUSE, THOSE OF YOU WHO ARE BILINGUAL UNDERSTAND THAT, SPEAKING, THINKING IN DIFFERENT LANGUAGES WILL CHANGE YOUR PERSPECTIVE BECAUSE OF THE WORDS YOU MAY, MAY NOT HAVE IN ONE LANGUAGE OR ANOTHER OR HOW THE MEANING CHANGES. FOR EXAMPLE IN YUROK THERE IS NOT A DIRECT TRANSLATION FOR THE WORD SORRY. SO, IN MY CULTURE YOU CAN'T JUST SAY SORRY AND THEN BE LIKE, OKAY, EVERYTHING IS FINE. RIGHT. WE ACTUALLY, WE ACTUALLY HAVE, HAD OLD SCHOOL, EQUIVALENT OF A LAWYER WOULD BEEN MY TRIBE OR HAD A DISPUTE OR COMPLICATION THERE

WOULD BE A THIRD PARTY WHICH WOULD ACT HOW A LAWYER DOES

NOW. TOW SEE WHAT WRONGS ARE DONE. AND WHAT, WHAT THE, THEY

WOULD HAVE MEMORIZED DIFFERENT PAYMENTS AND DIFFERENT,

REMEDIATIONS. SAY LIKE SOMETHING HAPPENED, LIKE, SAY, I -
ACCIDENTALLY TRIPPED YOU ON THE STREET. WHEN WE WERE

WALKING BY OR SOMETHING. AND I WOULD BE LIKE, OH, NO.

OR IF YOU SAY, A WORD IT DOESN'T MEAN -- AS MUCH AS IF YOU
